## Prospectus

**ArtHaus66 Gallery** is looking for artists with a coherent body of work and an original idea for a solo show. Please, submit your proposals in accordance with the following guidelines.

### ELIGIBLE ENTRIES

Must be 18 years of age or older. Original work in any medium (no video or site specific installations). Work completed within the last two years. Entries must be submitted as JPEGs. If a JPEG submission is not possible, please call 255-0872 to make alternate arrangements. Proposals are being accepted on an ongoing basis and we do our best to reply in a timely fashion.

### NUMBER OF ENTRIES

The number of pieces required for a solo show will depend upon dimensions. All entries must be accompanied by title, dimensions, medium and price. Please include a short bio/artist statement with your submissions for our online gallery. Artists will continue to be featured on [www.ArtHaus66.com](http://www.ArtHaus66.com) after the show ends and for up to 6 months.

### ENTRY FEE

There is no entry fee. **ArtHaus66 Gallery** retains 40% of any sale.

### INSTALLATION REQUIREMENTS

Accepted work must be ready to install. 2D work must be professionally framed and equipped with wire and/or D-rings. Paintings need not be framed but must have hanging devices in place.

### DELIVERY OF ENTRIES

Accepted entries can be hand delivered. Shipped entries must be in a reusable container with a prepaid return shipping label. Incoming and outgoing shipping costs are the responsibility of the artist. All artwork must be delivered or received no later than the agreed upon date.

### LIABILITY AND AGREEMENT

The Gallery will be responsible for any consigned work lost or damaged while in its possession. Any evidence of damage caused during transportation of the piece will be immediately reported to the artist. No alteration or repair of the damage will be undertaken without written authorization of the artist. Agreement to supply the gallery with artwork implies certification on the part of the artist that the artwork is in good condition and that every precaution has been taken so that it arrives to the gallery in prime condition.

The gallery is thus not responsible for any damage incurred during transportation of the artwork in route to the gallery or back to the artist. In the event of damage or theft during the exhibition of the artwork at our retail location in Albuquerque, New Mexico, ArtHaus66 Gallery will compensate the artist with the reimbursement of a percentage of the declared value of the artwork. In case of loss or theft, ArtHaus66 Gallery will reimburse the artist 60% of the net declared value of the artwork. Net value of the artwork is the retail value of such work minus the 40% gallery commission. In case of damage, ArtHaus66 Gallery will reimburse the artist 25% of the net declared value of the artwork, or, if the artist prefers, the agreed upon cost of the needed repair up to 25% of the net declared value.

The artwork remains the property of the artist. Consigned works may not be removed from ArtHaus66 Gallery premises for purposes of rental or installment sales without Artist's permission. Acceptance to exhibit is an agreement by the artist to all terms set forth in this prospectus.

#### **ARTHAUS66 GALLERY OPENING RECEPTION**

Exhibiting artists, friends, families and collectors will be invited to attend a publicly announced opening reception and exhibit of the original artwork. ArtHaus66 Gallery will provide professionally printed invitations to the artist prior to the opening.
